- 4 (a) Functions of Chief Acquisition Officer.—
- 5 Section 56(c) of title 14, United States Code, is amended
- 6 by striking "and" after the semicolon at the end of para-
- 7 graph (8), striking the period at the end of paragraph (9)
- 8 and inserting "; and", and adding at the end the following:
- 9 "(10)(A) keeping the Commandant informed of
- the progress of major acquisition programs (as that
- term is defined in section 581);
- 12 "(B) informing the Commandant on a con-
- tinuing basis of any developments on such programs
- that may require new or revisited trade-offs among
- 15 cost, schedule, technical feasibility, and performance,
- including—

10	"(2) Limitations on application.—
11	"(A) Small unmanned aerial sys-
12	TEMS.—The limitations in paragraph (1)(B) do
13	not apply to any small unmanned aerial system
14	that consists of—
15	"(i) an unmanned aircraft weighing
16	less than 55 pounds on takeoff, including
17	all components and equipment on board or
18	otherwise attached to the aircraft; and
19	"(ii) associated elements (including
20	communication links and the components
21	that control such aircraft) that are re-
22	quired for the safe and efficient operation
23	of such aircraft.
24	"(B) Previously funded systems.—
25	The limitations in paragraph (1) do not apply

1	to the design or acquisition of an unmanned
2	aerial system for which funds for research, de-
3	velopment, test, and evaluation have been re-
4	ceived from the Department of Defense or the
5	department in which the Coast Guard is oper-

23	"(a) In General.—Notwithstanding section
24	564(a)(2) of this title and section 2304 of title 10, and
25	subject to subsections (b) and (c) of this section, the Sec-

1	retary may acquire additional units procured under a
2	Coast Guard major acquisition program contract, by ex-
3	tension of such contract without competition, if the Direc-
4	tor of the Cost Analysis Division of the Department of
5	Homeland Security determines that the costs that would
6	be saved through award of a new contract in accordance
7	with such sections would not exceed the costs of such an
8	award.
9	"(b) Limitation on Number of Additional
10	Units.—The number of additional units acquired under
11	a contract extension under this section may not exceed the
12	number of additional units for which such determination
13	is made.
14	"(c) Determination of Costs Upon Request.—
15	The Director of the Cost Analysis Division of the Depart-
16	ment of Homeland Security shall, at the request of the
17	Secretary, determine for purposes of this section—
18	"(1) the costs that would be saved through
19	award of a new major acquisition program contract
20	in accordance with section 564(a)(2) for the acquisi-
21	tion of a number of additional units specified by the
22	Secretary; and
23	"(2) the costs of such award, including the
24	costs that would be incurred due to acquisition

1	schedule delays and asset design changes associated
2	with such award.
3	"(d) Number of Extensions.—A contract may be
4	extended under this section more than once."; and
5	(F) in section 581—
6	(i) by redesignating paragraphs (7)
7	through (10) as paragraphs (9) through
8	(12), respectively, and by redesignating
9	paragraphs (3) through (6) as paragraphs
10	(4) through (7), respectively;
11	(ii) by inserting after paragraph (2)
12	the following:
13	"(3) Customer of a major acquisition pro-
14	GRAM.—The term 'customer of a major acquisition
15	program' means the operating field unit of the Coast
16	Guard that will field the system or systems acquired
17	under a major acquisition program."; and
18	(iii) by inserting after paragraph (7),

20	"(8) Major acquisition program.—The term
21	'major acquisition program' means an ongoing ac-

8	(1) REQUIREMENT.—The Commandant of the
9	Coast Guard shall conduct a review of—
10	(A) the authorities provided to the Com-
11	mandant in chapter 15 of title 14, United
12	States Code, and other relevant statutes and
13	regulations related to Coast Guard acquisitions,
14	including developing recommendations to ensure
15	that the Commandant plays an appropriate role
16	in the development of requirements, acquisition
17	processes, and the associated budget practices;
18	(B) implementation of the strategy pre-
19	pared in accordance with section 562(b)(2) of
20	title 14, United States Code, as in effect before
21	the enactment of this Act; and
22	(C) acquisition policies, directives, and reg-
23	ulations of the Coast Guard to ensure such poli-

1	cies, directives, and regulations establish a cus-
2	tomer-oriented acquisition system.
3	(2) Report.—Not later than March 1, 2017,
4	the Commandant shall submit to the Committee on
5	Transportation and Infrastructure of the House of

9	(A) The recommendations developed by the

20	sition policies, directives, and regulations of the
21	Coast Guard as necessary to ensure the development
22	and implementation of a customer-oriented acquisi-
23	tion system, pursuant to the review under paragraph
24	(1)(C).

1	(d) Analysis of Using Multiyear Con-
2	TRACTING.—
3	(1) IN GENERAL.—No later than one year after
4	the date of the enactment of this Act, the Secretary
5	of the department in which the Coast Guard is oper-
6	ating shall submit to the Committee on Transpor-
7	tation and Infrastructure of the House of Represent-
8	atives and the Committee on Commerce, Science,
9	and Transportation of the Senate an analysis of the
10	use of multiyear contracting, including procurement
11	authority provided under section 2306b of title 10,

13	granted to the Navy under section 121(b) of the Na-

2	quisitions examined would meet the tests for the use
3	of multiyear procurement authorities.
4	SEC. 102. PROSPECTIVE PAYMENT OF FUNDS NECESSARY
5	TO PROVIDE MEDICAL CARE FOR THE COAST
6	GUARD.
7	(a) In General.—Chapter 13 of title 14, United
8	States Code, is amended by adding at the end the fol-
9	lowing:
10	"SEC. 520. PROSPECTIVE PAYMENT OF FUNDS NECESSARY
11	TO PROVIDE MEDICAL CARE.
12	"(a) Prospective Payment Required.—In lieu of
13	the reimbursement required under section 1085 of title 10,
14	for periods when the Coast Guard is not operating as a
15	service in the Navy the Secretary of the department in
16	which the Coast Guard is operating shall make a prospec-
17	tive payment to the Secretary of Defense of an amount
18	that represents the actuarial valuation of treatment or
19	care—
20	"(1) that the Department of Defense provides
21	to members of the Coast Guard, former members of
22	the Coast Guard, and dependents of such members
23	and former members (other than former members
24	and dependents of former members who are a Medi-
25	care-eligible beneficiary or for whom the payment for

1	treatment or care is made from the Medicare-Eligi-
2	ble Retiree Health Care Fund) at facilities under the
3	jurisdiction of the Department of Defense or a mili-
4	tary department; and
5	"(2) for which a reimbursement would other-
6	wise be made under such section 1085.
7	"(b) Amount.—The amount of the prospective pay-
8	ment under subsection (a) shall be—
9	"(1) in the case of treatment or care to be pro-
10	vided to members of the Coast Guard and their de-
11	pendents, derived from amounts appropriated for the
12	operating expenses of the Coast Guard;
13	"(2) in the case of treatment or care to be pro-
14	vided former members of the Coast Guard and their
15	dependents, derived from amounts appropriated for
16	retired pay;
17	"(3) determined under procedures established
18	by the Secretary of Defense;
19	"(4) paid during the fiscal year in which treat-
20	ment or care is provided; and
21	"(5) subject to adjustment or reconciliation as
22	the Secretary of the department in which the Coast
23	Guard is operating when it is not operating as a
24	service in the Navy and the Secretary of Defense de-
25	termine appropriate during or promptly after such

12	"(5) be synchronized with coordinated universal
13	time;
14	"(6) be resilient and extremely difficult to dis-
15	rupt or degrade;
16	"(7) be able to penetrate underground and in-
17	side buildings;
18	"(8) be capable of ready deployment to remote
19	locations;
20	"(9) take full advantage of the infrastructure of
21	the existing, unused Government long-range naviga-

21	retary of the department in which the Coast Guard is op-

23	coastwise endorsement for the vessel Apollonia (United
24	States official number 1266527).

1	SEC. 202. REIMBURSEMENT FOR NON-FEDERAL CONSTRUC-
2	TION COSTS OF CERTAIN AIDS TO NAVIGA-
3	TION.
4	(a) In General.—Subject to the availability of ap-
5	propriations and in accordance with this section, the Com-
6	mandant of the Coast Guard may reimburse a non-Fed-
7	eral entity for costs incurred by the entity for a covered
8	project.
9	(b) CONDITIONS.—The Commandant may not pro-
10	vide reimbursement under subsection (a) with respect to
11	a covered project unless—
12	(1) the need for the project is a result of the
13	completion of construction with respect to a federally
14	authorized navigation channel;
15	(2) the Commandant determines, through an
16	appropriate navigation safety analysis, that the
17	project is necessary to ensure safe marine transpor-
18	tation;
19	(3) the Commandant approves the design of the
20	project to ensure that it meets all applicable Coast
21	Guard aid to navigation standards and require-
22	ments;
23	(4) the non-Federal entity agrees to transfer
24	the project upon completion to the Coast Guard to
25	be operated and maintained by the Coast Guard as
26	a Federal aid to navigation;

1	(5) the non-Federal entity carries out the
2	project in accordance with the same laws and regula-
3	tions that would apply to the Coast Guard if the
4	Coast Guard carried out the project, including ob-
5	taining all permits required for the project under
6	Federal and State law; and
7	(6) the Commandant determines that the
8	project satisfies such additional requirements as may
9	be established by the Commandant.
10	(c) Limitations.—Reimbursements under sub-
11	section (a) may not exceed the following:
12	(1) For a single covered project, \$5,000,000.
13	(2) For all covered projects in a single fiscal
14	year, \$5,000,000.
15	(d) Expiration.—The authority granted under this
16	section shall expire on the date that is 4 years after the
17	date of enactment of this section.
18	(e) Covered Project Defined.—In this section,
19	the term "covered project" means a project carried out
20	by a non-Federal entity to construct and establish an aid
21	to navigation that facilitates safe and efficient marine
22	transportation on a federally authorized navigation chan-
23	nel.
