- 6 (a) IN GENERAL.—Not later than 180 days after the
- 7 date of enactment of this Act, the Administrator of the
- 8 Environmental Protection Agency shall establish a
- 9 stormwater infrastructure funding task force composed of
- 10 representatives of Federal, State, and local governments
- 11 and private (including nonprofit) entities to conduct a
- 12 study on, and develop recommendations to improve, the
- 13 availability of public and private sources of funding for
- 14 the construction, rehabilitation, and operation and mainte-
- 15 nance of stormwater infrastructure to meet the require-
- 16 ments of the Federal Water Pollution Control Act (33
- 17 U.S.C. 1251 et seq.).

1	(b) Considerations.—In carrying out subsection
2	(a), the task force shall—
3	(1) identify existing Federal, State, and local
4	public sources and private sources of funding for
5	stormwater infrastructure; and
6	(2) consider—
7	(A) how funding for stormwater infrastruc-
8	ture from such sources has been made avail-
9	able, and utilized, in each State to address
10	stormwater infrastructure needs identified pur-
11	suant to section 516(b)(1) of the Federal Water
12	Pollution Control Act (33 U.S.C. 1375(b)(1));
13	(B) how the source of funding affects the
14	affordability of the infrastructure (as deter-
15	mined based on the considerations used to as-
16	sess the financial capability of municipalities
17	under the integrated planning guidelines de-
18	scribed in the Integrated Municipal Stormwater
19	and Wastewater Planning Approach Frame-
20	work, issued by the Environmental Protection
21	Agency on June 5, 2012, and dated May,
22	2012), including consideration of the costs asso-
23	ciated with financing the infrastructure; and
24	(C) whether such sources of funding are
25	sufficient to support capital expenditures and

1	long-term operation and maintenance costs nec-
2	essary to meet the stormwater infrastructure
3	needs of municipalities.
4	(c) Report.—Not later than 18 months after the
5	date of enactment of this Act, the Administrator shall sub-
6	mit to Congress a report that describes the results of the
7	study conducted, and the recommendations developed,
8	under subsection (a).
9	(d) STATE DEFINED.—In this section, the term
10	"State" has the meaning given that term in section 502
11	of the Federal Water Pollution Control Act (33 U.S.C.
12	1362).
