10	"(1) IN GENERAL.—Except as provided in para-
11	graph (3), sections 552 and 552b of title 5, this
12	part'';
13	(2) in the second sentence by striking "Section
14	552 of title 5, United States Code, applies" and in-
15	serting the following:
16	"(2) Timing of Application.—Except as pro-
17	vided in paragraph (3), sections 552 and 552b of

3	"(A) Information.—The requirements of
4	the second sentence of section 552b(b) of title
5	5 shall not apply to any portion of an Amtrak
6	meeting and subsections (d) and (e) of section
7	552b of title 5 shall not apply to any informa-
8	tion pertaining to any portion of an Amtrak
9	meeting otherwise required by section 552b of
10	title 5 to be disclosed to the public in any case
11	in which Amtrak properly determines that such
12	portion or portions of the meeting or the disclo-
13	sure of such information is likely to involve—
14	"(i) contract negotiations, including
15	negotiations for contract procurements and
16	agreements, the disclosure of which would
17	imperil or compromise the competitive po-
18	sition of Amtrak;
19	"(ii) collective bargaining agreements
20	or any terms and conditions that are pro-
21	posed for inclusion in any collective bar-
22	gaining agreement, including the negotia-
23	tion of terms and conditions with employ-
24	ees or representatives of employees of Am-
25	trak; and

1	"(iii) with respect to any individual
2	who is a prospective officer, employee, or
3	contractor or an officer, employee, or con-
4	tractor employed or appointed by Amtrak,
5	matters involving the employment, appoint-
6	ment, termination of employment, terms
7	and conditions of employment, evaluation
8	of the performance of, promotion or dis-
9	ciplining of any such individual, unless all
10	such individuals whose rights could be ad-
11	versely affected request in writing that the
12	matter or matters be discussed at a public

14	"(B) Additional application.—In addi-
15	tion to the information described in subpara-
