3 (a) IN GENERAL.—Chapter 51 of title 14, United
4 States Code, is amended by adding at the end the fol5 lowing new sections:

6 "§5116. Annual plan for Coast Guard operations in 7 the Pacific

"(a) IN GENERAL.—Not later than December 31, 8 2025, and annually thereafter, the Commandant of the 9 10 Coast Guard, in consultation with the Secretary of State 11 and Secretary of Defense, shall submit to the appropriate 12 congressional committees a plan for Coast Guard operations in the Pacific region for the year after the year 13 14 during which the plan is submitted. Such plan shall include, for the year covered by the plan, each of the fol-15 16 lowing elements:

17 "(1) A list of objectives for Coast Guard en18 gagement in the Pacific region in support of Depart19 ment of State and Department of Defense missions.

"(2) An assessment of the capabilities of the
 Coast Guard to support Department of State and
 Department of Defense missions in the Pacific re gion.
 "(3) A list of any areas in the Pacific region
 where an increased Coast Guard presence would bet ter support Department of State and Department of

9 "(4) The projected demand for Coast Guard en10 gagement in the Pacific region from the Department
11 of State and the Department of Defense for the year
12 covered by the plan and the subsequent 10 years.

"(5) An assessment of whether the Coast
Guard will be able to meet such projected demand
for the year covered by the plan, including a list of
any factors limiting the ability of the Coast Guard
to meet such projected demand.

18 "(6) A summary of the resources needed for the
19 Coast Guard to meet such projected demand for the
20 year covered by the plan, including—

21 "(A) staff;

22 "(B) infrastructure, including shore infra23 structure;

24 "(C) administrative and logistical support;25 and

1 "(D) technology.

2 "(7) Any other matter as determined relevant3 by the Commandant.

4 "(b) FORM.—Each plan under subsection (a) shall be
5 submitted in unclassified form, but may include a classi6 fied annex.

7 "(c) BRIEFING REQUIRED.—Not later than February
8 15, 2026, and annually thereafter, the Commandant shall
9 provide to the appropriate congressional committees a
10 briefing on the annual plan required under subsection (a)

5 "(a) IN GENERAL.—Not later than February 15, 2026, and annually thereafter, the Commandant of the 6 7 Coast Guard shall submit to the appropriate congressional 8 committees a detailed budget display for Coast Guard op-9 erations in the Pacific region for the fiscal year after the 10 fiscal year during which the budget display is submitted. 11 The Commandant shall base such budget display on the 12 projected demand for Coast Guard engagement in the Pacific region as identified in the most recent annual plan 13 developed under section 5116 of this title. Such budget 14 15 display shall include, for the year covered by the budget display, the following information: 16

17 "(1) With respect to procurement accounts,
18 amounts displayed by account, budget activity, line
19 number, line item, and line item title.

20 "(2) With respect to research, development,
21 test, and evaluation accounts, amounts displayed by
22 account, budget activity, line number, program ele23 ment, and program element title.

24 "(3) With respect to operation and maintenance25 accounts, amounts displayed by account title, budget

activity title, line number, and subactivity group
 title.

3 "(4) With respect to military personnel ac4 counts, amounts displayed by account, budget activ5 ity, budget subactivity, and budget subactivity title.
6 "(b) FORM.—Each display under subsection (a) shall
7 be submitted in unclassified form, but may include a class8 sified annex.

9 "(c) BRIEFING REQUIRED.—Not later than February 10 15, 2026, and annually thereafter, the Commandant shall 11 provide to the appropriate congressional committees a 12 briefing on the budget display required by subsection (a) 13 for the fiscal year after the fiscal year during which the 14 briefing is provided.

15 "(d) APPROPRIATE CONGRESSIONAL COMMITTEES
16 DEFINED.—In this section, the term 'appropriate congres17 sional committees' has the meaning given such term in
18 section 5116 of this title.".

19 (b) CLERICAL AMENDMENT.—The table of sections
