7	(1)" and inserting "Subparagraph (A)";
8	(3) in subsection (f), by redesignating para-
9	graphs (1) through (4) as subparagraphs (A)
10	through (D), respectively, and adjusting the margins
11	accordingly;
12	(4) by redesignating subsections (b) through (g)
13	as paragraphs (2) through (7), respectively, and ad-
14	justing the margins accordingly;
15	(5) in subsection (a), by striking "In General"

4	those obligations of the United States heretofore and
5	hereafter incurred which are authorized to be paid
6	out of the Maritime Security Trust Fund, includ-
7	ing—
8	"(A) the Assistance for Small Shipyards
9	Program under section 54101 of this title;
10	"(B) the Federal Ship Financing Program
11	under section 53702 of this title; and
12	"(C) other similar maritime expenses, in-
13	cluding maritime education and workforce ex-
14	penses, as determined by the Administrator of
15	the Maritime Administration.
