EMERGENCY MANAGERS URGE CONGRESS TO PASS DISASTER REFORMS

Lexington, KY - The National Emergency Management Association (NEMA) and International Association of Emergency Managers (IAEM-USA) today call upon Members of Congress to swiftly pass H.R. 302 which includes the Disaster Recovery Reform Act (DRRA). For nearly a year, IAEM-USA and NEMA worked with the House Transportation and Infrastructure and Senate Homeland Security and Governmental Affairs Committees in creating meaningful reforms of programs at the Federal Emergency Management Agency (FEMA).

"The DRRA provides us the necessary tools to ensure the strength of emergency management by streamlining disaster response programs, adding flexibility into the system, and supporting programs such as the Emergency Management Assistance Compact," said NEMA Vice President, Brad Richy. "We appreciated the opportunity to work with the committees as they developed this legislation and are pleased to see provisions included which bolster efforts to focus on predisaster mitigation and give those of us managing disasters the tools to be successful."

"IAEM is pleased to have been a partner in the development of the Disaster Recovery Reform Act, a bill that will significantly enhance federal support for pre-disaster mitigation," stated IAEM-USA President Nick Crossley, CEM." The DRRA will help provide the resources needed to make our communities safer and more resilient. On behalf of all emergency management professionals who wake up every day thinking about and planning for the next disaster, I strongly urge the House and Senate to approve H.R. 302 this week."

The provisions comprising the DRRA are Division D of H.R. 302, and expected to see Congressional action this week.

Established in 1974, NEMA represents the emergency management directors of the 50 states, territories, and the District of Columbia. These professionals are responsible to their governors for all-hazards emergency preparedness, mitigation, response, and recovery from all emergencies, disasters,

and threats to the homeland. NEMA is a non-profit, non-partisan organization headquartered in Lexington, Kentucky, and an affiliate of the Council of State Governments.
