

**AMENDMENT TO THE AMENDMENT IN THE  
NATURE OF A SUBSTITUTE TO H.R. \_\_\_\_\_  
OFFERED BY MR. WEBSTER OF FLORIDA**

At the appropriate place in title III, insert the following:

**1 SEC. 3\_\_\_. HURRICANE AND COASTAL STORM DAMAGE  
2 RISK REDUCTION PROJECT IMPLEMENTA-  
3 TION.**

4 (a) IN GENERAL.—Notwithstanding any requirement  
5 of the Secretary for a project described in subsection (b)  
6 to comply with the memorandum of the Corps of Engi-  
7 neers entitled “Standard Estates – Perpetual Beach  
8 Nourishment and Perpetual Restrictive Dune Easement”  
9 and dated August 4, 1995, the Secretary shall carry out  
10 each project described in that subsection, for the remain-  
11 ing term of the construction agreement for the project,  
12 in a manner consistent with the previously completed ini-  
13 tial construction and periodic nourishments of the project,  
14 including by carrying out, at full Federal expense when  
15 authorized by law, emergency response work to prepare  
16 for flood, hurricane, and other natural disasters and to  
17 support emergency operations, repairs, and other activities  
18 under section 5(a) of the Act of August 18, 1941 (com-

1 monly known as the “Flood Control Act of 1941”) (55  
2 Stat. 650, chapter 377; 33 U.S.C. 701n(a)).
