

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 3935
OFFERED BY MR. PERRY OF PENNSYLVANIA**

At the end of the bill, add the following:

1 **TITLE X—FREEDOM TO FLY ACT**
2 **OF 2023**

3 **SECTION 1001. SHORT TITLE.**

4 This title may be cited as the “Freedom to Fly Act
5 of 2023”.

6 **SEC. 1002. PROHIBITION ON IMPLEMENTATION OF VAC-**
7 **CINATION MANDATE.**

8 The Administrator may not implement or enforce any
9 requirement that employees of air carriers be vaccinated
10 against COVID–19.

11 **SEC. 1003. PROHIBITION ON VACCINATION REQUIREMENTS**
12 **FOR FAA CONTRACTORS.**

13 The Administrator may not require any contractor to
14 mandate that employees of such contractor obtain a
15 COVID–19 vaccine or enforce any condition regarding
16 COVID–19 vaccination status of employees of a con-
17 tractor.

1 **SEC. 1004. PROHIBITION ON VACCINE MANDATE FOR FAA**
2 **EMPLOYEES.**

3 The Administrator may not implement or enforce any
4 requirement that employees of the Administration be vac-
5 cinated against COVID-19.

6 **SEC. 1005. PROHIBITION ON VACCINE MANDATE FOR PAS-**
7 **SENGERS OF AIR CARRIERS.**

8 The Administrator may not implement or enforce any
9 requirement that passengers of air carriers be vaccinated
10 against COVID-19.

11 **SEC. 1006. PROHIBITION ON IMPLEMENTATION OF A MASK**
12 **MANDATE.**

13 The Administrator may not implement or enforce any
14 requirement that employee of air carriers wear a mask.

15 **SEC. 1007. PROHIBITION ON MASK MANDATES FOR FAA**
16 **CONTRACTORS.**

17 The Administrator may not require any contractor to
18 mandate that employees of such contractor wear a mask.

19 **SEC. 1008. PROHIBITION ON MASK MANDATE FOR FAA EM-**
20 **PLOYEES.**

21 The Administrator may not implement or enforce any
22 requirement that employees of the Administration wear a
23 mask.

1 **SEC. 1009. PROHIBITION ON MASK MANDATE FOR PAS-**
2 **SENGERS OF AIR CARRIERS.**

3 The Administrator may not implement or enforce any
4 requirement that passengers of air carriers wear a mask.

5 **SEC. 1010. DEFINITIONS.**

6 In this title:

7 (1) **ADMINISTRATOR.**—The term “Administra-
8 tion” means the Administrator of the Federal Avia-
9 tion Administration.

10 (2) **AIR CARRIER.**—The term “air carrier” has
11 the meaning given such term in section 40102 of
12 title 49, United States Code.
